(Conservation) easements

- legal concept
 - “easement”, “servitude”, “covenant”, “restriction”, “agreement” ...
 - a creature of real property law
 - separation of property ownership and use rights
 - servient and dominant estate (or party, “the public”)

- possible applications
 - many things are possible, but not everything is in the public interest
